Jacqueline is a social psychologist whose expertise lies at the intersection between education and healthcare interventions for the psychosocial wellbeing of youth and socially excluded communities. She is a chartered member and associate fellow of the British Psychological Society, and a senior fellow of the Higher Education Academy. Jacqueline is the interim Associate Dean (Global Engagement) in the Faculty of Humanities and Social Sciences, University of Portsmouth.

## Keynote Speaker Dr Zahra Murad



Zahra is a senior lecturer at the Economics and Finance Subject Group in the Faculty of Business and Law. She joined the University of Portsmouth in December 2017. Zahrah's research is on behavioural and experimental economics. She conducts laboratory, online and field experiments to study economic decision making. Her research lies on the crossroads of economics, management, political science and social psychology.

Zahra co-founded Portsmouth Economics Experiments Research Lab (PEER) with Wolfgang Luhan, which investigates important economic issues such as incentives, motivation, productivity, and cooperation.

Completing her BSc and MSc at Bilkent University in Turkey, Zahra completed her PhD at the University of Nottingham. She was a part of CeDEx, one of the first and most active behavioural research groups in the UK. Zahra worked as a research fellow at the University of Surrey for the project "Delivering Better For Less: Improving Productivity and Motivation in Public Sector". She has taught undergraduate and postgraduate level modules at Surrey, including Game Theory and MSc Microeconomics.
